- Deadlines reviewing exams

Amsing: In the UG-regulations, the review deadline for exams is 10 days, for students this is very important. On the other hand, teachers may have difficulty meeting this deadline. Teachers have to organize the exams carefully: they can arrange support when foreseeing not meeting the deadline. This topic was discussed with the programme directors and the boards of examiners and they were asked to take measurements. Also for theses the review deadline is 10 days. This seems especially tight. We want to see if a deadline adjustment for theses to 15 days is possible.

Amsing will provide the council with an evaluation in October.

Topics for discussion 03

What is the role of the faculty in dealing with events relevant to members of the community? This following the earthquake in Turkey and Syria.

- Aarts stresses that it is important to contact the colleagues it affects to express your concern and compassion.
- To avoid confusion among staff and students, communication from the FB should be harmonized with that of the CvB. This is why communication sometimes is delayed.
- Different types of calamities request different kinds of support for students and staff. Students always can go to the study advisors and staff to the management or the HR-advisor.
- During the corona period, a crisis team had been formed that included the department directors. The FB will discuss the topic of communication in the case of calamities with this group.

o5 Announcements from the Faculty Board

- There is a vacancy for a professor/director for the Teacher Programme. The first round did not lead to an appointment. An external advisor has been asked to give an advice on the current position and organisation of the Education Department.
- The FB has received the first results of the employee survey. All employees will receive the results in two weeks.
- The UG is facing financial difficulties caused by various price increases. Therefore, the UG launched the Back in Balans 2026 programme, in which 5 consultation tables in various disciplines have been tasked with proposing cost-reducing measures. The proposals have been submitted to the CvB. It does not concern personnel cuts, but the measures certainly will have an impact.

05.01 Preventiecoördinator Arbo voor de Binnenstad

05.01 What is the aim of the "Kunstcommissie" and do they receive time for this?


06 OER Teaching and Examination Regulations

Teaching and Examination Regulations Bachelor/Master > Marking Examinations and publications of marks.

- What can students do if they do not have their grade after 10 working days? What are the student rights? Are there many exemptions still being given by programme committees to teachers to delay publications of grades?
- Why did the education monitor conclude that the teacher workload at the faculty is fine, when many teachers do not meet their grading deadlines?

We want to hold on to the 10 days marking deadline, but we hope that students will understand that it is sometimes not possible to meet that deadline because of unforeseen circumstances. For getting this understanding good communication with students is crucial.





We also understand that it works both ways: if we are very strict in deadlines for students, students will also expect teachers to meet deadlines. There needs to be a balance in universal rules that are especially needed in programmes with large numbers of students and the human dimension.

We have discussed the topic with DOWs, but we will also address it with the Exam Committees.

What is the purpose of this document?

Two purposes: (1) The monitor is important for the internal teaching quality assurance in the faculty, and (2) The Board of the University must submit an annual summary education report to the minister. The teaching monitors of all faculties are the bases for such a report.

The "blokoverleggen" at PedOn are very beneficial and the timing seems very sufficient. Teachers publish this kind of information at the beginning or right before the start of the course, so discussing the deadlines among the teachings within one block a week before the start seems reasonable. This good practice is now also implemented at AOLB.

It is on the agenda. The idea is to organize courses directly related to the themes of the sectorplan. The internal memo was meant to introduce the ideas to the DOWs. The plan as such is the outcome of the discussion. The next step is an implementation plan. We can share this with the Council.
